- 1. Call to Order Louise Yurko called the meeting to order at 10:02 a.m.
- 2. Welcome Louise Yurko welcomed everyone to the meeting and started the introduction around the table.
- 3. Adopt Agenda
  Walter LaRoque motioned to approve agenda, seconded by Jean Garner,
  unanimously approved
- 4. Approval of Minutes February 1, 2017 Jean Garner motioned to approve minutes, seconded by Walter LaRoque, unanimously approved
- Approval of RAAC & STHL nominees A handout of the proposed RAAC & STHL nominees were given out for review. Tye Roy & Pat Mills were

nominated to become new RAAC members and stood to introduce themselves and give a small detail of their history.

Woody Brinson was suggested to be STHL-D after Janet Jones resigned. Darrell Grubbs motioned to approve Woody Brinson as STHL-D, seconded by David Jones, unanimously approved.

Ann Thomas-Hughes was suggested to be Craven County STHL-A. Walter LaRoque motioned to approve Ann Thomas-Hughes as STHL-A, seconded by Jean Garner, unanimously approved.

6. Directors Report – Andi Reese, Interim Deputy Director, gave the director report. She stated HCCBG monitoring has been completed for FY 16/17. The AAA is still waiting to hear from DAAS about allocations for FY 17/18. Victor Heinrich asked of the budget cuts if they affect the AAA HCCBG. Andi explained the difference between Meals on Wheels and Home Delivered Meals. HCCBG includes Home Delivered Meals, Meals on Wheels is a different funding source. The AAA was monitored by DAAS and there was no finding of being non-compliant.

- b. Family Caregiver Andi Reese gave out a handout on Project CARE and talked about vouchers that are available in each county. January Brown has been teaching a PASTA class in Jones county and is trying to set up a class in Onslow County.

There was talk of Project CARE being a big topic at the STHL meeting. Discussion of what Project CARE is and what the vouchers cover took place and a future topic of Rosalyn Pugh coming to talk to the group was suggested.

- c. HCCBG Andi Reese stated monitoring is on track and completed.
- d. LCA/MFP Andi Reese explained LCA (local contact agency) and option counseling, which helps make the decision to move home easier.
  - She has 2 follow ups on ones that have moved; 6 LCA monthly referrals and 6 active MFP transitions.
- e. Other-no other comments

### 8. County Comments

a. Carteret – Victor Heinrich stated the Senior Center has been monitored and was given a low risk rating. Victor attended the STHL meeting in January; The Senior Center sent Valentine's Day cards to legislatures; there is a plan for a Charleston Trip; Pine Knoll Shores is trying to become Age Friendly Community but zoning voted against it.

- b. Craven Lavick Williams stated that a Walk/Talk will be planned in the near future; Carolyn Bland stated the Senior Center still hosts Grandparents & Memory Café; and a Mothers/Daughter Tea will be hosted for Mother's Day.
- c. Duplin Darrell Grubbs stated that the Senior Center has offered an Alzheimer's Care workgroup; Elder Abuse workshops; AARP tax aide workshops. Upcoming events include a Volunteer Appreciation dinner and a Senior Health Fair
- d. Greene David Jones reported there is a trip planned to Savannah, GA in September; TaiChi group did a demo at the Greene County Health Department open house; Greene County has 20 participates in the Neuse River games; Volunteer Breakfast is coming up; During Older American's Month there will be a senior dance and pool tournament. Elder Abuse Walk is June 15<sup>th</sup>.
- e. Jones Della Ancrum reported of activities at Jones County Senior Center; Art & Crafts; gardening project; Bingo; Brain Teaser; Blood Pressure/Sugar checks; Grandparents Lunch on St. Patrick's Day and they are preparing for Senior Games coming up
- f. Lenoir Walter LaRoque reported that the Senior Center is going under their Scope Recertification; they had an AlzNC Memory Walk on April 8<sup>th</sup>; Volunteer Lunch is on April 19<sup>th</sup>; and there will be a Line Dancing performance on the 26<sup>th</sup>.
- g. Onslow Joyce DuPalevich reported Onslow Senior Center has a new newsletter format; a fund raiser, lasagna dinner for Friends of Seniors; Senior Games are April 22<sup>nd</sup> and 29<sup>th</sup>. Senior trips to Disney Epcot at the end of April and Spirit of Ireland is planned for October; Volunteer Tea is April 18<sup>th</sup>.
- h. Pamlico Ann Thomas-Hughes reported that there has been an increase in ramps and home delivered meals; Pamlico County has 15 participates in the Senior Games; Aging Well Expo in May at the Community College. Joan Gracie spoke at the Senior Center about STHL. Tye Roy stated that there is a Fairy GodParents Circle they have raised needed items for kids in schools.
- i. Wayne Linda Harper reported that senior games was in February; There was a Peggy Seegars Day in March; Matter of Balance classes were offered in January and February. Martha Bryan stated that may 20th will be Wings over Wayne.
