FASTLANE & TIGER Federal Grant Update – Patrick Flanagan stated that the new federal grant FASTLANE has been reviewed and no projects in the DERPO area fit the criteria of the grant. There was discussion about funding match with projects that are approved for the grant.

17. NCDOT Division Reports

- d. Division 2: Jeff Cabaniss gave handouts and highlighted some projects in Division 2. In Craven County TIP Project R-2514 US 17 bypass is 8% complete; Sidewalk projects is 80-85% complete; Landscape Enhancement Project in Bridgeton to be completed in April, 2016; Joint replacement on Bridge over Trent River to be completed in June. Multiple secondary road resurfacing to be completed by November. In Carteret County US 70 improvements is 45% complete; North River Bridge is 12% complete. In Pamlico County the NC 304 widening has completion date of June, 2016; Bay City repairs are 79% complete. For more information contact jcabaniss@ncdot.gov
- e. Patrick Riddle gave a handout and highlighted some projects in Division 3. Duplin County NC 24 widening project is combined and clustered together for completion dates of March 14, 2017 and March, 2018. Patrick also highlighted some resurfacing projects with the completion date of December 2015. For more information contact priddle@ncdot.gov
- f. Planning Branch: Lee Cowhig gave updates on Craven, Jones & Onslow County CTPs. Jones County CTP is in draft and presented to the public for comment on Feb. 9th. Onslow County CTP has completed the survey and presentation to the public of what a CTP is will be presented April 11th. Craven County CTP is waiting on hiring staff.

18. FY '16-'17 Planning Work Program

Patrick Flanagan presented the budget for our RPO in the upcoming year. This document outlines the projects we will work on and the products we will produce for NCDOT. The majority of this year's budget is focused on SPOT, current STIP project development and the multiple CTPs we will be helping with in 2016 and 2017.

Don Baumgardner motioned to approve program, seconded by Kyle Garner, unanimously approved.

19. FY '16-'17 Five Year Calendar

Patrick Flanagan presented an outline of the future work the RPO hopes to accomplish in the next couple of years. The idea is that projects funnel from the Five Year Calendar into the PWP.

Gene Foxworth motioned to approve calendar, seconded by Katrina Marshall, unanimously approved.

20. ACTION: DERPO Local Input Point Assignment Methodology

Patrick Flanagan presented methodology and some minor text changes. Each MPO and RPO in the state must have a locally adopted methodology that will direct how local input points are assigned to the various projects in Prioritization 4. The ECRPO SPOT subcommittee has met and reviewed this methodology and submitted it for approval. NCDOT has conditionally approved this methodology. There was small discussion of the target distribution of points.

Katrina Marshall motioned to approve methodology, seconded by Josh Edmondson, unanimously approved.

21. Other Business – Patrick Flanagan stated there is a sign ceremony in Goldsboro for the new interstate project.
